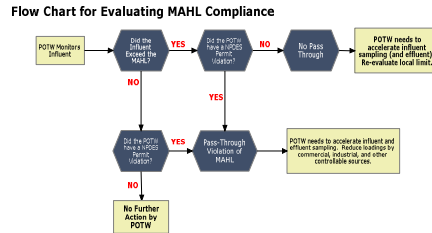


# Pretreatment Training for Local Governments (POTWs)
